T1 Silver birch - raise crown by removal of low primary branches to 4m above ground level

T2 Beech - prune back branches extending south over neighbours' garden by up to 2m from the distal end

T3 Maple - re-pollard at approximately 5m above ground level

T4 Amelanchier/T5 Acer trilobum reduce by up to 1m in height and spread to maintain proportions with garden
